The mission of Rescuing Leftover Cuisine ("RLC") is to become the world's most widely used solution for companies and individuals to eliminate food waste in their communities, making food rescue sustainable and universal, and food hunger a thing of the past.

Form 990, Part III, Line 4a - Program Service Accomplishments

The largest program in 2016 was a food rescue operation established with KIND Snacks. In three warehouses in California, New Jersey, and Pennsylvania, KIND Snacks produces large amounts of food including bars, grains, and cereals. RLC works with the corporate KIND Snacks offices on an ad hoc basis to get obsolete inventory donated that is on average thousands of pounds of boxes of food that would otherwise been thrown out. More than 100,000 people and children have benefitted from the healthy food donated by KIND Snacks. In 2016, the partnership resulted in 139,046 pounds of food rescued.

RLC established its second largest program service in 2016 with an airport in New Jersey. RLC partners with a management company to get a group of vendors within this airport to donate their excess food at night 7 days a week. RLC van drivers pick up on average 400 pounds of assorted sandwiches, fruit cups, and other prep-made food that would have been wasted and deliver it to a network of soup kitchens nearby. More than 300 people benefit from the food donated on each delivery completed. In 2016, the partnership turned 102,635 pounds of food that would have been thrown out to over 85,529 meals fed to those in need.

The third largest food rescue operation of 2016 was a continued food rescue operation that established in 2015 with PepsiCo. In Portland, Oregon, a PepsiCo factory of

Frito Lays produces large amounts of snacks including chips, pretzels, and others. RLC continues to work with this Frito Lays factory as needed, picking up on average thousands of pounds of boxes of snacks that would otherwise been thrown out. We deliver it by truck to many homeless shelters and soup kitchens around the Portland area. More than 50,000 people total have benefitted from the food donated by Frito Lays. In 2016, the partnership resulted in 84,014 pounds of rescued food that would have been thrown out but instead accompanied meals fed to those in need.

Management reviewed a draft of the form 990 and provided edits to the tax preparer. After this process was performed, the Form 990 was sent to the full board of directors prior to being filed with the IRS.
